#### Child and Family Therapy

"In therapy, some children start to believe that they are bad children because of their problems, and will accept their behavior as "who they are". With this intervention, called externalizing, we are able to separate the problem from the child. As shown below, the problem is Bossy and not the child. The reasoning behind this is because children are not problems. What abusive men in their lives have taught them is the problem."

She works to raise awareness of domestic violence and increase understanding of victims' and children's needs so that victims get the community support they need in their efforts

# Volunteer Spotlight: Pat Eshbaugh

Artemis Center lost a dear friend and longtime supporter, Pat Eshbaugh, who passed away unexpectedly on Tuesday, August 1, 2017. Pat was a dedicated volunteer babysitter with Artemis Center for close to nine years. She helped to organize our volunteer group of childcare providers that supported survivors of intimate partner violence and their children by providing tender love and care to children while their moms attended Artemis support groups. Pat enjoyed talking to, playing with, and getting to know the children that came to Artemis each week. She and her volunteer group not only gave their time, but brought in donations for Artemis Center pantries regularly. Pat also made sure her team would always provide school supplies for our children. Artemis Center staff, the parents attending support groups and their children, that Pat tirelessly served will miss her dearly.



#### **Client Story**

"Though the story of Crystal's\* journey is not yet fully complete, as her advocate who has worked with her, I can attest to the fact that she has transformed herself from victim of domestic violence to strong survivor. I am proud of her and the work she has done to move herself forward and away from harm. I facilitated a support group that Crystal came to in February 2017.

She had left her batterer and an extremely physically, mentally, and emotionally violent relationship in Toledo, Ohio. She was honest about her unhealthy coping strategies and her struggling with an eating disorder. She appeared tiny and frail and stated that she only weighed 95 pounds. Crystal is an extremely intelligent young lady who had graduated from the University of Toledo with a degree in law, and was set to take the bar exam. Studying for and taking the bar exam were both put on hold during the course of her relationship with her batterer. Her batterer had convinced her that his needs came before hers, and that she would never be able to pass the bar

exam and become an attorney. Sadly, Crystal started to believe this to be true.

#### Legislation Updates

Supreme Court Decision Limits
Batterers' Access to Guns

"The Office on Violence Against Women (OVW) is pleased to share important news about a recent Supreme Court decision that will enhance the ability of federal prosecutors to keep guns out of the hands of batterers. On March 26, the Court unanimously ruled in *United States v. Castleman* that federal law makes it a crime for people convicted of misdemeanor domestic violence offenses, however minor, to possess guns.

#### Healing Through Art

"Artemis Center's Healing Through Art Room allows our clients to safely express difficult feelings and how to cope with traumatic memories and triggers. Art helps provide a voice to our survivors while they are going through the healing process. Creating images becomes an empowering outlet where past experiences do not have to be spoken out loud. This helps survivors gain a sense of grounding, strength, safety, understanding and hope.

Clients who attend our support groups use the art room to create beautiful works of art. One project allowed clients to paint stepping stones, each stone symbolizing steps they have taken throughout their healing process. Some of the stones can be seen in the flower gardens of the Artemis Center. Our survivors are proud to have their art displayed for all who visit our building."

#### **In Their Shoes Project**

Artemis Center is proud to announce the start of *In Their Shoes: Teens and Dating Violence* Program. This program is a scenario-based training designed to help







participants talk about what dating is like for today's teens-from their perspective. Participants become teen characters, make choices about their relationships, and see what happens. This program is intended to help teens see a snapshot of unhealthy relationships and provides a platform for healthy discussion about relationships and what opportunities exist to support those experiencing them.

In June, as a pilot for the program, teens in the Montgomery County Juvenile Courts Reclaiming Futures program were able to experience *In Their Shoes* first-hand. The students spent a few hours going through the simulation and then talked about the experience in an "in-the-round" discussion.

Teens were able to give feedback during the discussion and also continued the conversation after the experience.

"My mother was physically abused and it was heartbreaking to see this every day, especially since I was taught that no man should raise his hand to a woman. Seeing my mother get beat by her boyfriend was not easy, but she was strong and made it out of the situation. It took her some time, but she did it. The In Their Shoes experience hit very close to home and made me realize how lucky I am that my mom made it out alive. In Their Shoes helped me understand that if you are in an abusive relationship there is always available and you are not alone. " -Casey\*, 16 years old.
